

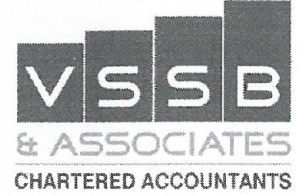

Basis for Opinion

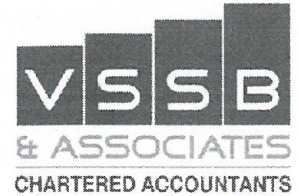
